The Morrow County Health District is looking for name suggestions for our Reproductive Health and Wellness Program, and we need YOUR help!

WHAT WE ARE: The Reproductive Health and Wellness Program is a grant awarded to the Morrow County Health District by the Ohio Department of Health. It is funded by Federal Title X Program, Maternal and Child Health Block Grant, and State General Revenue funds. MCHD was awarded this grant in 2016, and has been operating our clinic since December of that year.

WHAT WE DO: The purpose of the Reproductive Health and Wellness Program is to improve the overall health of women and men. We do this by promoting healthy lifestyles, lowering barriers to care, and providing access to contraceptives and reproductive health services. We can see men and women of all ages by appointment in our clinic, and no one will be turned away if they are unable to pay.
